- Sealed or electronic bids must be submitted to the office stated below or through PPMO website www.bolpatra.gov.np on or before 12.00 Hrs. of 24th January 2019(2075/10/10 B.S). All bids must be accompanied by a Bid Security as specified in notice with validity period for 30 days beyond the validity period of the bid in accordance with clause 19 of ITB. Bids received after this deadline will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend in person at the Office of Jhapa Rural Municipality, Taghandubba, Jhapa immediately after the submission deadline at 13:00 Noon 24th January 2019(2075/10/10 B.S).
- Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
- Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
